RULES AND REGULATIONS FOR BURIALS AT ST. JOHNS CEMETERY:
Gravesites must be paid in full before burial takes place and/or prior arrangements for prepayment of sites with Board approval. Opening and closing arrangements for full burials to be made with funeral home. St. Johns opens and closes cremations only \$85.00 - due on or before burial date - \$85.00 - check made out to St. Johns Cemetery.

Must be a Valley resident or have a Wishkah affiliation (approved by the board). Verification of headstone ordered; required within 30 days of burial. Headstones must be in place within 90 days of burial (including inurnments) cremations headstones must be flat and flush to the ground in the cremation section.

Any additions, amenities, changes to gravesite (s) - and/or grounds (i.e. decorations, plantings, structures, statuary) must have prior approval of the board. If maintenance of grounds (i.e. mowing, weed eating, edging) is impeded. Board is authorized to remove. Please no glass containers. By signing this agreement you acknowledge you have read this full agreement and will abide by the rules
